A. First Selectman Shawn Murphy provided backup information as asked for by the BOF.

B. First Selectman Shawn Murphy also wanted to make sure BOF puts on Agenda the upcoming Boom Bridge Road Project appropriation. He is not happy with the new procedure that the BOF has put in place.

4. BOS 2016 / 2017 Budget Presentation
