## **COUNSELORS – SUMMER PLAYGROUND /SAFETY CAMP/KIDDIE CAMP**

### QUALIFICATIONS:

1. 14 years of age on or before June 1, 2016
2. North Stonington Residents will have preference
3. Prior participation in volunteer and/or paid service involving children and/or adolescents (ie. Babysitting).
4. Graduation from a babysitting course is desirable
5. CPR and First Aid training are desirable
6. Available to work the entire playground/camp session schedule

### DUTIES:

1. Work under the supervision of the Summer Safety Camp Director, Playground Director, and senior Counselors to implement playground activities.
2. Primary concern will be for the safety and welfare of Playground and Kiddie Camp participants.
3. Maintain small groups and stress cooperation rather than competition. Must work to promote enthusiasm to make Playground and Kiddie Camp experiences enjoyable. Assist the participants with the tasks at hand.
4. Participate in Playground, Safety Camp, and Kiddie Camp activities
5. Be actively involved and direct children, NOT passively “babysit”.
